## Safeguarding Children: Recognition, Referral and the Child Protection Process

Learning Outcomes - by the end of this training, participants will be able:

- To demonstrate an understanding of key legislation and procedural guidance underpinning child protection
- To know the function of the Safeguarding Children Board and the rationale for child practice reviews
- To define the categories of child abuse and identify the outcomes of possible abuse within the current social context and in line with government guidance
- To recognise how values, beliefs and attitudes can influence the judgements made in relation to child protection
- To demonstrate an understanding of roles and responsibilities within a multi-agency child protection context.
- To describe your role within safeguarding children
- To explain the child protection process from referral through to conference

**Target Group:** This course is specifically aimed at all professionals and volunteers across Gwent, who may be required to make referrals regarding children and their families. Participants may come from a wide variety of settings, for example, housing, early years, primary health services, education and community settings and other care providers.

The course can be used to refresh your existing knowledge of safeguarding, as it will provide an understanding of the referral process through to child protection conference.

**The South East Wales Safeguarding Children Board** is a multi-agency partnership that has the strategic lead for safeguarding children in this region. One of the statutory duties of the Board is to provide safeguarding children training across agencies and sectors. This includes basic introductory courses to more specialised training.

### **How to apply:**

1. Access the South East Wales Safeguarding Children Board website - ([www.sewsc.org.uk](http://www.sewsc.org.uk)), click on the Training page.
2. Scroll down to Safeguarding Courses and scroll again to Safeguarding Children – Recognition, Referral and the Child Protection Process, click on the link to apply for this training – this will take you through to the booking system.
3. If you haven't already done so, register your profile on our automated booking system (you are only required to register your profile once). If you have registered your profile previously, log on with your User name and Password
4. Once logged on to the booking system, click on the Courses push button, then click on SEWSCB and scroll down and click on Safeguarding Children – Recognition, Referral and the Child Protection Process.
5. Click on enrol me/sign up and follow the process to apply for the training.
6. You and your line manager will receive a confirmation email to confirm your application (please note applying does not guarantee a place).
7. You will be emailed in due course to advise whether or not you have been successful in gaining a place.
